

Dear Parents and Families:

Happy spring, officially. We hope that you enjoyed the recent conferences for your child, and please know that we see these opportunities as an important connection to furthering home and school partnerships. We always appreciate your feedback on your experience at conferences, so please don't hesitate to send a note directly to your child's teacher or myself.

We continue to acknowledge and recognize students who demonstrate Grit & Perseverance, as well as those who demonstrated Kindness & Compassion. I have spent time at lunch and sometimes in classrooms explaining where we really want to see acts of kindness and compassion, such as when an adult (or child) is talking, we should give them our undivided attention and make eye contact to show that we are listening to what they are saying. This often seems a severely overlooked expectation in our modern society and children infrequently appear to realize that this is viewed as disrespectful by the one speaking. Recess, after-school play and unsupervised spells are other times that I typically hear of acts of kindness and compassion going array. As such, my message to our students is always this: It is when no one is around to supervise your behavior that your true character will be on display. And we (the adults) will find out if you fail to act with kindness or compassion, and we will not accept it.

Personal Devices in School Rules

I am a huge supporter of technology for because of its potential for making life and work more efficient and effective. Youngsters today have grown up in a world that they know of no time that smartphones, tablets, laptops and smart-watches, didn't exist, and it is incumbent upon us as adults and their guides to monitor and lead them to use it safely, respectfully and courteously, especially when interacting and communicating with others. Simply preventing them from using it does little to achieve this aim. Therefore, I want our students to see the school and I as a supporter and guide for safe and considerate technology use.

I have spoken quite often in the last few weeks to 5th grade students regarding the use of technology in general, as well as my position on its use in school. I have begun speaking to 4th grade students also, and I will continue to do so at opportune times, as I think its essential that this unchartered territory is addressed and not left to chance. While we, the adults, are digital immigrants, we always need to keep firmly in mind that our general life experience is still a necessary guide for our children despite them being often more tech-familiar. I have informed the 5th grade students (and by the end of next week, all of 4th grade) that I believe that technology is importance for helping us communicate and work more efficiently. However, there are times and a place for using smartphones and smartwatches, and that school is not it. Thus, I have informed them that if they do bring a smartphone to school, it is to be (1) switched off before entering school, (2) placed in their backpacks and (3) not brought out until they are out of school.

If these rules are broken, the phone will be confiscated and you, the parent, will be called to come and collect the phone. Your child will then not be permitted to bring his/her phone to school unless I authorize it. Personal tablets are also subjective to the same rules.

I have also informed the students that the school bus is also considered being in school. However, they can choose to use their device, but they must be extremely cautious and mindful of not misusing them. Misuse includes, but is not limited to, taking pictures, sending and posting inappropriate or mean-spirited messages, etc. Such issues are subject to the same rules as outlined above.

Smart-watches are somewhat trickier, yet subject to the same general conditions. I don't have an issue with smart-watches being worn (just like I don't have an issue with smartphones being brought to school), but the moment that it becomes in any way shape or form a distraction to the one wearing it or to others, it will be confiscated. Following this, you will be called to come and collect it and it won't be permitted in again until I authorize it.

Please discuss these rules and expectations with your child and decide if it is necessary for them to have such devices in school. Regardless, if they become a distraction to the educational environment, even minimally so, they will not be permitted in.

Such devices will also not be permitted on field trips, as they provide a risky potential for misuse with limited monitoring capacity. Adult chaperones and the school would be liable for issues related to misuse of devices on field trips under their supervision, which would immediately tar the experience for all.

A Few FYIs

As a reminder, when your child is absent from school, and especially for periods that extend beyond a day or so, I want you to be aware that teachers cannot provide current schoolwork in the absence of providing students with the necessary and associated instruction. Dear Parent or Guardian,

The Fairfield Public Schools will join millions of students across the United States in the Smarter Balanced Assessment (SBA) Test this spring.

For our schools, all students in grades 3-5 will participate in Smarter Balanced Assessment (SBA) testing in both mathematics and English language arts/literacy (ELA). SBA testing for ELA will take place between April 1-26, and math testing will take place between April 29-May 17. Please note, students in grades 5 are also required to take the NGSS (Next Generation Science Standards) Standard test. The NGSS Standard Test for all elementary schools will be administered between May 20-24. The NGSS Standard Field Test is an untimed assessment administered on a computer.

The SBA tests are not timed however; it will take approximately 5 total hours to complete both content areas of English Language Arts and Math. Testing will be administered on a computer and scheduled over multiple sessions of about 60 minutes each. It is worth noting that the assessment is adaptive and therefore students may complete the assessment in shorter intervals.

To comply with federal and state statute, participation in the test is required. Please note that Smarter Balanced will adhere to all federal and state privacy laws, including but not limited to the Family Educational Rights and Privacy Act (FERPA).
